Welcome & Introductions - Greg Lech

- Introductions of in-person and virtual attendees
- Call for approval of May 2025 STAC/MACC meeting minutes
 - Motioned to approve by Dave, seconded by Josh, opposed by none
- Vote: Dave Smith co-chair
 - Motioned to approve by Josh, seconded by LeeAnn, opposed by none
- NEP overview – Kathy Klein
 - The President zeroed out NEP funding but was later restored by congress
 - The hatchery project is at a decision making point right now due to all funding being federal thus far and there still being a funding gap.

 - Juvenile mussel release to take place tomorrow (August 29) at Palmyra Cove

STAC member presentations

- Kelly Good – *Watersheds as systems: understanding upstream decisions and downstream consequences*
 - Source water protection, microplastics in watersheds, and resilient infrastructure systems: main research foci in Kelly's research group

- Identification of point source discharge of iodine at the watershed scale to inform monitoring efforts and wastewater permitting
- Steve Goldsmith – *Road salt impacts to the greater Philadelphia region water supply: Insights from a multi-sector collaborative approach*
 - What is the risk of road salt to the Philadelphia area?
 - Switching from use of road salt to brining using could adjust road salt input 20-40%
 - Easiest option for reduction into waterways is to use less salt
 - DRBC formed a workgroup to deal with chloride input which recently met with a local municipality on how to limit inputs
- Jenn Gius – *Oyster Stock Assessment in Delaware Bay, NJ*
 - Stock assessment survey is designed to evaluate density of beds to make management decisions in Delaware Bay
 - Managing the NJ Delaware Bay oyster stock is a collaborative approach with varying entities, each with independent members and duties
 - Oysterfest in Bivalve, NJ – October 18:

- Emmy Caspar – *Researching American Oystercatchers on the Delaware Bay*
 - Birds used “backpack” tags good for 3 years to monitor habitat use
 - Open to collaboration with other groups implementing living shorelines to help enhance shorebird habitat

STAC Workplan Review

- Shad white paper subcommittee update
 - Final product is complete! It will be circulated amongst the STAC soon, likely with two-week timeline for members to review
 - A press release is also being coordinated in the next month or so prior to wider circulation
- Onboarding subcommittee update
 - Subcommittee consists of Leah, Greg, Lesley Baggett, and Dane Ward, and the subcommittee met earlier this month
 - Introductory information to be collected from all members including short bio, photo, etc., for later upload to the PDE website for potential new members and the general public to access

- Next white papers – Delaware Bay beach sustainability, osprey-menhaden dynamics
 - Sediment updates are 10+ years old; focus would be solely on Delaware Bay beach restoration
 - Machine learning, satellite passing to create maps – are these applicable in DE Bay like they are on the oceanfront?
 - Incorporation of replenishment data with storm data
 - Kristy's company works with a dredge firm in southern NJ, and dredge material for beneficial reuse could be considered relative to replenishment as well.
 - LeeAnn will follow up with the committee regarding this, and we will add an agenda item for our workshop planning meeting in December to discuss further.
 - Loss of nesting and foraging habitats, and beach grass decline could also be considered
 - Osprey vs menhaden dynamics
 - There are no clear issues with menhaden fishery currently but osprey are starving to death; what other dynamics could be at play that could be affecting the osprey population/causing them to die from starvation?
 - We could set up a Dropbox for STAC members to access to drop in reports and updates
